Internally, the rooms, built of stone, are characterized by vaulted ceilings with star and barrel vaults. The entire building is in good condition, but needs a conservative restoration, connection to the electricity supply in three-phase mode, tanks for water storage, gas heating and fireplaces.

The property is easily accessible from the provincial road that connects Ceglie Messapica to San Michele Salentino, just  $3\frac{1}{2}$  kilometers from the town of Ceglie Messapica and about 15 kilometers from Ostuni and a little more (about 20 kilometers) from the Adriatic Sea. Brindisi International Airport is easily reached in about 30 – 35 minutes by car.
